Treated open hole with 120 bbls lease crude oil mixed with 30 gal. Fre-flo "C". Ran tbg., pump and rods. Set pumping unit and motor and started well pumping on 9-23-70.

Well status changed from a flowing oil well to a pumping oil well, eff. 9-23-70.
