We propose to plug this well in the following manner. 5 1/2" csg. is set at 3811' with open hole to 3870'. Cementing will be as follows, 25 sks. at bottom of hole; 25 sks. at stub of 5 1/2" csg.; 25 sks. at top of salt section; 25 sks. at bottom of 8-5/8" csg. set at 292' and 10 sks. at top of surface with regulation marker. Drilling mud will be left between each plug.
