Amerada Hess Corporation respectfully request administrative approval for an 80 acre non-standard gas proration unit on J. H. Williams "A" Well No. 2 located in Unit M, (330' FSL, 330' FWL), Sec. 34, T19S, R37E, Lea County, New Mexico.


J. H. Williams "A" Well No. 2 was originally drilled and completed as an oil well in Grayburg San Andres Zone. During 1977, W. K. Byrom recompleted well in Eumont Zone receiving Administrative Orders; NSL-839, April 21, 1977, Non-Standard Location, and NSP-1048, May 2, 1977, dedicating 160 acres to Non-Standard Gas Proration Unit. Well test after recompletion re-classified well as an oil well in Eumont Zone. Amerada Hess Corporation acquired J. H. Williams "A" Well No. 2 and rights to 80 acres from Byrom Oil Company in September, 1989.

Well is currently producing 1/4 B.O./D., 1/4 B.W./D. & 44 MCFGPD.

Enclosed is an area map and C-102 dedicating 80 acres to well. All off-set operators have been notified of this application by certified mail.
