Gentlemen:

By letter dated January 10, 1957, The Texas Company was notified by Mr. R. F. Montgomery that, in order to comply with Order R-553, it must obtain a connection for sale of casinghead gas or secure a no-flare order from the Commission for its State of New Mexico "CC" NCT-1, Well No. 1, located in Section 35, T-19S, R-37E, Eumont Pool, Lea County, New Mexico.

The State of New Mexico "CC" NCT-1 Lease contains 40 acres and is comprised of the NE/4 of the NE/4 of Section 35, T-19S, R-37E, Lea County, New Mexico. The attached plat was prepared to show the location of Well No. 1, offset ownership, and the location of tank battery. The Texas Company has negotiated a contract with Warren Petroleum Company to take the 49.0 MCF of casinghead gas per day now being flared by Well No. 1, a top allowable well which produces with a gas-oil ratio of 1140 cubic feet per barrel. We anticipate Warren's gathering system, the nearest point to which is approximately 1370 feet to the west of our well, will be completed to this well in the near future. Therefore, a temporary no-flare order for a period of three months, commencing March 2, 1957, is respectfully requested for the State of New Mexico "CC" NCT-1, Well No. 1.
