DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Run #4 joints 7-5/8-inch casing, total of 2698 feet, set at 2711 feet. Cemented with 800 sacks regular cement with 85 gal, 100 sacks regular neat cement. Plug on bottom at 3:15 P.M., 3-1-55. Circulated 100 sacks. Slurry weight 12.8 and 15.5#. Centralizers at 2706, 2666, and 2626 feet.

Tested casing with 1000# GWP for 30 minutes. Test O.K. No drop in pressure.

Now preparing to drill with air for mud.
