1. Pull rods and pump.
2. Tag bottom with tbg. and tally out of hole.
3. If hole is clean to bottom, fire 500 grains per foot string shot from 3861-3885 feet followed by a 1000 grain per foot string shot over the same interval. If hole is not clean, clean out to total depth and then fire string shots.
4. Run focused or induction log and open hole caliper from total depth to 3830.
5. Return well to production.
