At T. D. 165 In Red Rock we ran 165 ft. of 12 1/2" Good Second Hand Casing and cemented with 45 sx. by the Halliburton method.

After allowing to set 72 hrs. we drilled plug and bailed dry.

After standing 2 hours we reran bailer and found WSO complete.

We are now drilling ahead at 688 with a dry hole.
