**197' of 12 1/2" new lapweld casing was set in this well and cemented with 150 sacks of El Toro Cement.**

**Hole was bailed dry and allowed to stand undisturbed for thirty minutes.**

**1200# pump pressure was applied to the casing and fittings and allowed to stand undisturbed for thirty minutes. There was no drop in pressure. The cement plug was then drilled from inside the casing. 1200# pump pressure was again applied and allowed to stand undisturbed for thirty minutes. There was no drop in pressure. Drilling was resumed, after hole had been bailed dry, allowed to stand undisturbed for one hour and no water had accumulated.**
