FULL DETAILS OF PROPOSED PLAN OF WORK  
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Plan to pull rods, pump and tubing, Run Baker retrievable cementer on tubing and squeeze 6-1/4" open hole from 5650' to 5711' with 75 sacks reg. Incor cement. Drill out to 5675' and perforate San Angelo zone thru 7" casing approx. 12' from Schlumberger logs with 2 shots per foot. Run tubing, Brown Duc-Pak Packer and PSI nipple with straight thru tool inserted and swab test Blinbry open hole from 5650' to 5675'. If necessary acidize Blinbry open hole from 5650' 5675' and pull straight thru tool. Run Blanking tool and acidize San Angelo perforations with 500 gals. acid. Swab and test. Resume production.
