DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Repaired leak in 9-5/8" casing as follows:

1. Pumped water in 9-5/8" casing annulus and broke circulation on 13-3/8" casing.
2. Pumped 93 sacks cement down 9-5/8" casing and circulated estimated 10 sacks out 13-3/8" casing.
3. Closed in 13-3/8" casing and squeezed to 250#. There was no drop in pressure.
4. 13-3/8" - 9-5/8" annulus pressure 8#. 9-5/8" - 7" annulus pressure 8#. Released pressure and pressure blew down.
5. Checked 13-3/8" - 9-5/8" annulus. No pressure. Checked 9-5/8" - 7" annulus. No pressure.
6. Returned well to production.
