DETAILS OF WORK

It is proposed to drill a well on the above described location to a total depth of approximately 5700 ft. in the Blincy pay with the following casing and cement program: Set 13 3/8" OD casing at 600' and cement with sufficient amount of cement to circulate. Set 9 5/8" OD or 8 5/8" OD casing at 3000 ft. and cement with sufficient amount of cement to circulate. Set 7" or 5 1/2" OD casing at 5700 ft. and cement with 500 cc. perforate and acidize as necessary for production. If any difficulty should be encountered while drilling, making it necessary to alter the casing program we will file a "Notice of Intention to Change Plans".


I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
