320' - T.D. - Red Bed - Finished drilling 17-1/2" hole to 320' @ 10:30 AM, 5-29-54.
Ran a total of 8 jts of 13-3/8" OD Casing set @ 316' w/300 sacks cement. Pumped plug to 296' @ 4:30 PM, 5-29-54. Max. Press. 300#. Cement Circulated. WOC 12 hours. Tested 13-3/8" OD Casing w/800# before and after drilling cement - OK. Drilled cement & plug from 296' to 316' and circulated hole to bottom @ 320'. Started drilling 12-1/4" hole from 320' @ 3PM, 5-30-54.
