Propose to plug back & acidize as follows:
Release packer and P.O.H. Dump 8' of sand from DBTD (4254') to 4248' and cap from 4248'-4215' w/ Hydromite. RIHW/PI packer and acidize w/ 100 gals 15% HCl per 1 foot interval. Flush w/ 30 BBLs clean water. Re-run original injection equipment. Set packer at 3948' and pressure test. Return well to injection.
