Supplementing procedure outlined in C-103 dated 12/9/53

We propose to:

Kill well, pull tubing and packer. Set retrievable bridge plug and test casing for lowest leak. Locate free point and cut off casing below leak. Pull casing and run new 7" casing with casing pack-off overshot for tie-in. After running logs, rerun tubing with packer and fill annulus with corrosive inhibitor. Swab well and put on production.
