MI and RUSU 9-28-88 and pull injection packer and tubing. Run bit and tag fill at 4206' and clean out to 4240'. Run packer and set at 4136' and acidize from 4144-80, 4190-97, 4202-10 and 4216-20 with 4500 gallons of 20% NE HCl. Run injection packer and tubing and displace hole with packer fluid. Set packer at 3918' and test to 540 psi for 30 minutes. RD and MOSU 9-29-88 and return well to injection.

PPWO: 386 BWIPD at 680 psi.
PAWO: 1533 BWIPD at 820 psi.
