Form C-101 filed to drill well to 8200' and test Devonian. Operator now intends to drill well to approximately 10,000 to test the McKee.

1. 13-3/8" 48# casing was cemented at 323' w/400 sacks, cement circulated.
2. 8-5/8" 36# casing was cemented at 4260' w/220 sacks.
3. Operator will run 5-1/2" liner to 8059' and cement with 300 sacks. Top of liner to be at 4224'.
4. Drill a 4-3/4" size hole to approximately 10,000' to test the McKee.
5. In the event of production, Operator will run 4" liner and cement with 100 sacks.
