The elevation of the derrick floor above sea level is 3699 ft.

DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work)

We propose to drill at the above location with cable tools to an approximate depth of 3700 feet in the Seven Rivers. 13 3/8 inch casing will be cemented at approximately 70 feet with 100 sacks of cement. A string of 10 3/4 inch casing will be mudded at 750 feet and 8 5/8 inch casing at 1290 feet. An oil string of 5 1/2 inch casing will be landed at approximately 3650 feet. The 10 3/4 inch and 8 5/8 inch casing will be pulled and the 5 1/2 inch casing cemented to surface with approximately 1500 sacks cement. The well will be tested natural and if necessary will be treated with 1000 gallons regular acid.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

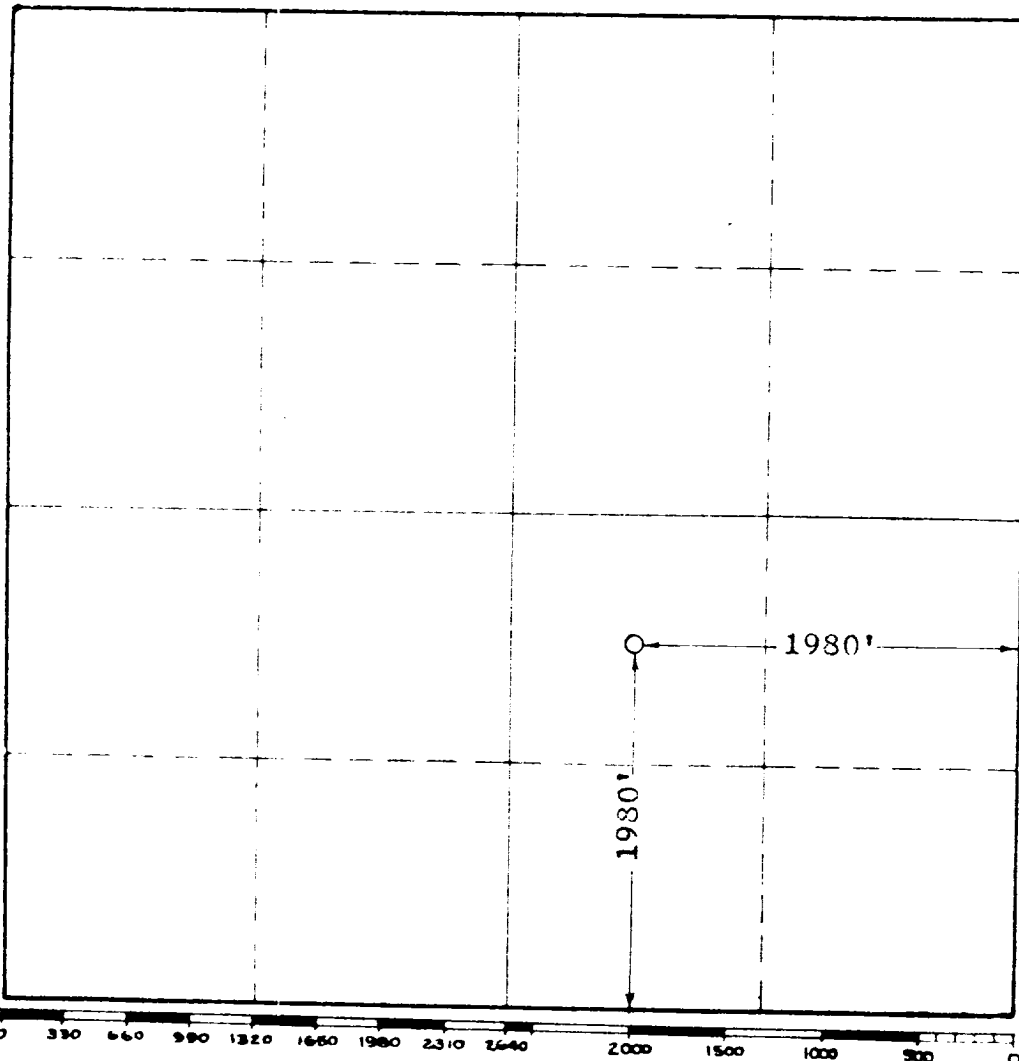
