Finished drilling 8-3/4" hole to 3996' @ 7:15 P.M. 10-6-54. Ran 131 jts. of 7" OD casing set @ 3996'. Cemented w/800 sacks. Pumped plug to 3929' @ 8:30 P.M. 10-7-54. Maximum pressure - 650#. Ran temperature survey and found top of cement @ 2173' or 29.25% fill. 24 hrs. WOC. Tested 7" OD casing before and after drilling cement - OK. Drilled plug and cement from 3929' to 3991'. Continued with completion operations.
