and when it found a highly public and additional consultation in the B&K and T&K sections of the work was a major step forward in the way the work was addressed by an agency in the national domain. However, no formal agreement was ever signed, and the following year, results of work of national bodies (in terms of ongoing or completed projects and other activities) were not shared with the relevant departments. It seemed to follow a pattern typical for reports of completed activities, which are often sent to the relevant departments but are not used in the way intended. This is a point in favour of the 'no formal agreement' approach, and a reason to believe a formal agreement for reports of completed activities may be a bad idea.
