Set bridge plug at 7800' with 1 sack cement on top abandoning McKee Zone. Perforated 5-1/2" casing from 5620' to 5712'. Acidized perforations with 7500 gals. 15% acid with rock salt diverter in 5 stages, swabbed, recovered salt water, squeezed perforations and reperforated 5-1/2" casing in Blinebry Zone from 5691' to 5711'. Acidized perforations with 1500 gals. 15% acid. Swabbed salt water and recovered bridge plug. Well is temporarily abandoned. No change in producing status.
