Ran 178 Jts (5713') 7" OD 20# & 23# Grade J-55 SS casing. Set and cemented at 5724' with 325 sacks 4% Gel and 150 sacks Neat on bottom. Plug at 5657'. Maximum pressure 1600#. Job complete by Howco 7:45PM 1-28-55.

After waiting over 30 hours, tested 7" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled cement plug 5657' to 5722'. Tested with 1000# for 30 minutes. No drop in pressure.
