DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 90 Jts (2886') 9-5/8" OD 36# Gr J-55 SS casing. Set and Cemented at 2899' with 1600 sacks 4% Gel and 150 sacks Neat on bottom. Maximum pressure 1500#. Plug at 2865'. Circulated approximately 5 sacks cement. Job complete by Hewco 6:15AM 2-21-55.

After waiting over 30 hours, tested 9-5/8" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled cement plug from 2865' to 2899'. Tested below casing shoe with 800# for 30 minutes. No drop in pressure.
