Cactus Drilling Company spudded 11" hole at 12:00 noon on 5/14/63. On 5/14/63, 8-5/8" OD 24# J-55 ST&C casing was run and set at 430' with 225 sx. cement. Circulated with 25 additional sx. cement. After WOC 18 hours tested casing with 600 PSI for 30 minutes with no loss in pressure. Reduced hole to 7-7/8" at 430' and resumed drilling operations.


