## Instructions

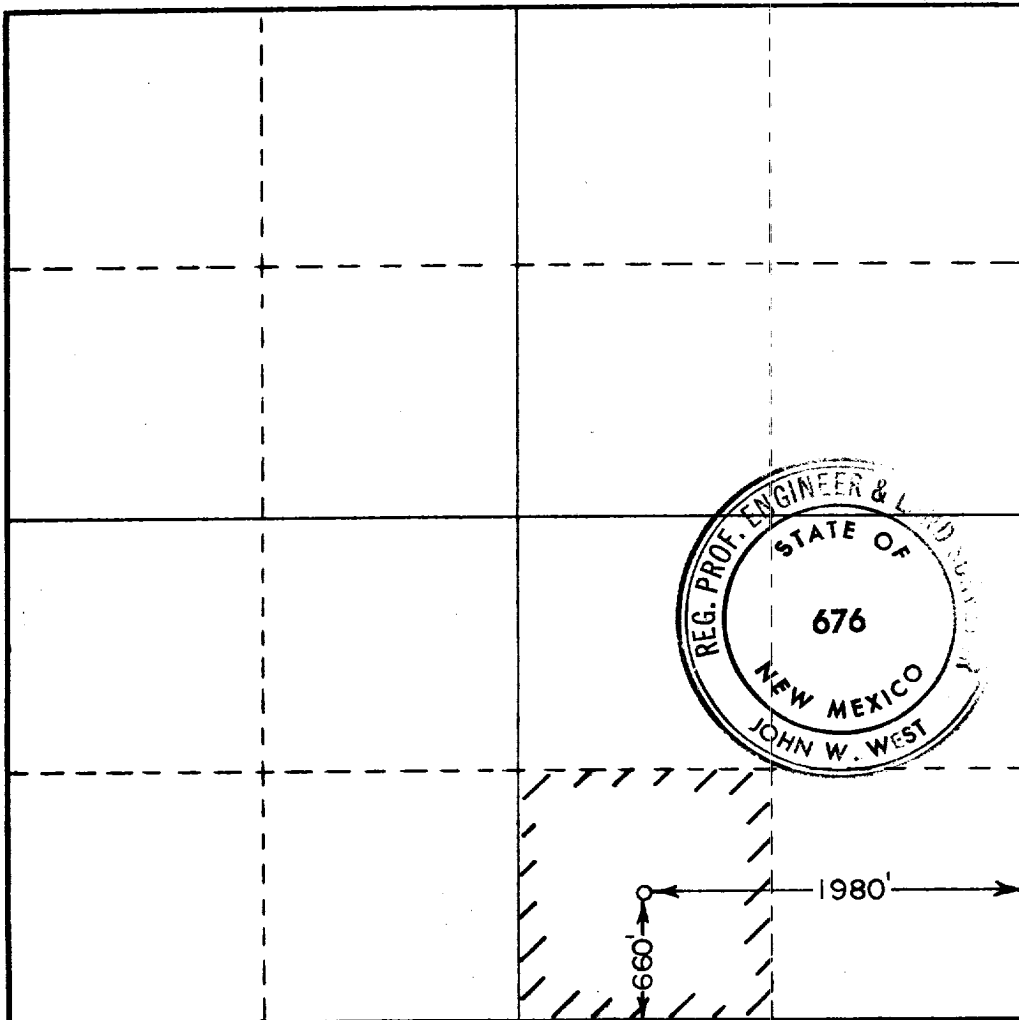
