17. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work) SEE RULE 1103.

The subject well was spud 10-19-83. Drilled to a total depth of 40'. Set 14" conductor pipe and cemented with 2 yards of Redi Mix. Moved in and rigged up Young Rig #5. Began continuous drilling operations 10-21-83, with a 12-1/4" bit. Drilled to a total depth of 1495'. On 10-23-83, ran 8-5/8", 24# J-55 casing and set at 1495'. Cemented with 875 sx of class C cement with 1% CaCl. Circulated out 220 sx of cement. WOC 18 hrs. Pressure tested casing 600 psi for 30 min. Held OK. Reduced bit to 7-7/8" and resumed drilling.
