The subject well was spud 11-26-85 with a 26" starting hole. Drilled to 40' and set 14", 36.71" conductor pipe. Cemented with 4yds Redi-Mix. MUKU Cactus Rig No. 54 and began continuous drilling operations 12-6-85 with a 12 1/4" bit. Drilled to a TD of 1590'. Ran 8 7/8", 24# K-55 casing and set at 1590'. Cemented with 11005X class C with 1% ACK₂. Circulated 200 5X of cement. WOC 18 hrs. Pressure tested casing 1000 psi for 30 mins - ok. Reduced bit to 7 7/8" and resumed drilling.
