On 5/27/01 run 33 jts. of 8-5/8" 24# J-55 casing (set @ 1422'). Cement w/440 sx Class "C" Light (12.5 ppg, 1.99 yld). Tail w/200 sx Class "C" + 2% CaCl2 (14.8 ppg, 1.34 yld). Circulate 135 sx to pit.

Test pipe rams/casing to 500 psi.
