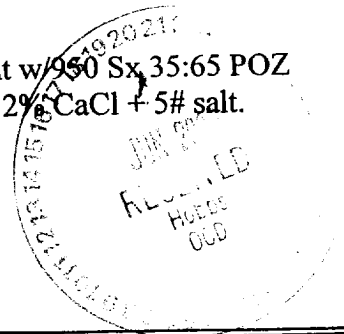

Cement w/300 Sx Class "C" + 2% CaCl + 1/4# celloflake + 3# Gilsonite; Circulate 30 bbls cement to pit. Wait on cement 8 Hrs. Nipple up BOP. Install H2S equipment as per NMOCD orders.

6/12/02 TD 7 7/8" hole @ 5,031'; Run 5 1/2" csg and set @ 5,030'. Lead Cement w/950 Sx 35:65 POZ + 6% Bentonite + 3% salt + 1/4# Celloflake, tail w/250 Sx 50:50 POZ + 2% CaCl + 5# salt. Ready to complete and test Pearl Queen formation.
