DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 111 Joints (3510') 7" OD 20# Grade J-55 SS casing. Set and cemented at 3524' with 1650 sacks 1% Gel and 150 sacks Neat on bottom. Plug pumped to 3490'. Maximum pressure 1500#. Circulated approximately 75 sacks cement. Job complete 7:30AM 7-6-54.

After waiting over 30 hours, tested 7" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled cement plug from 3490' to 3524'. Tested cement below casing shoe with 1000# for 30 minutes. There was no drop in pressure.
