Pull 2-3/8" OD Tubing, Run cast iron Bridge Plug and set at approximately \pm 7460' with two sacks cement on top. Perforated 5 1/2" OD Casing opposite Hare Simpson (Second Sand) from 7390' to 7413' with two shots per foot. Rerun 2-3/8" OD Tubing with packer and acidize with 500 gallons mud acid. Swab and test.
