DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 126 joints 7" OD, 20#, New, J-55 Grade, Range 2 casing. Cemented shoe and string at 3964 feet KDB with 250 sacks 4% gel plus 100 sacks neat cement. Placed 250 gallons of mud acid ahead of cement. Float collar at 3950. Cleaned out to 3950 and tested casing with 1000 psi pump pressure for 30 minutes, held OK, cement job OK.
