DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

We acidized this well on March 29, 1951, with 1500 gallons of 15% HCL after first displacing 200 gallons of jelly-seal into the formation to seal off the existing permeability. After the acid treatment, the well flowed an average of 8 BOFH on 1/2" choke.
