Dear Sir:

The subject wells are producing from the Pennsylvanian member of the Queen formation and are all located within the defined areal extent of the Summit Pool. It is requested that they be reclassified from the Archedown Pool to the Summit Pool. Submitted with this letter is Form C-119, Certificate of Compliance and Authorization to Transport Oil and Natural Gas.

The following pertinent data pertaining to the geology of these three wells is presented for your information. The formation tops of the first two wells were picked from drilling samples and the formation tops of the third well have been picked from a radio activity log of the well.
