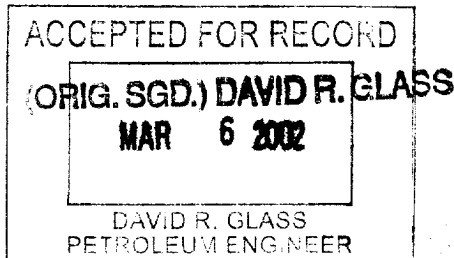

- 12/03/01 Test anchors. Move in and rig up. Pump hot water down tubing. Pull out of hole and lay down rods. Nipple up BOP.
- 12/04/01 Pull out of hole and lay down tubing. Run in hole w/ bit & casing scraper. Clean out fill. Circulate hole clean.
- 12/07/01 Run in hole w/ 2-3/8" polylined tubing & packer, set packer @ 5668'. Displace backside w/ packer fluid and pressure test casing to 500# for 30 minutes - OK.
- 12/10/01 Hook well up to injection system and put on injection.
- 02/06/02 Pressure test casing and chart - OK. (See attached chart)

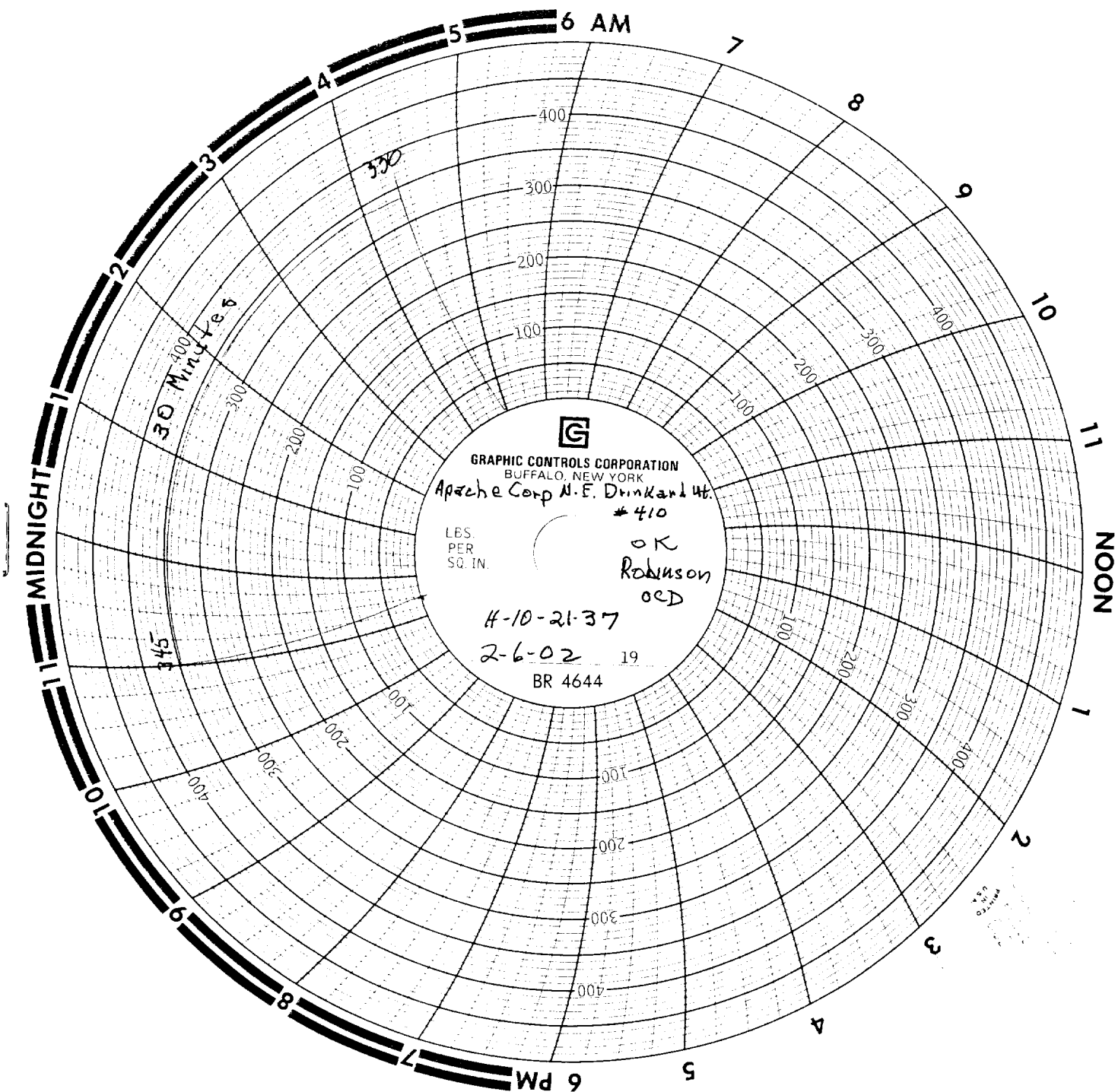
