1. The Commission has received information from the
2. Bureau of Land Management, U.S. Department of the Interior,
3. that certain lands in the State of New Mexico are
4. owned by the United States and are being offered for
5. sale to the highest bidder. The Commission has
6. been advised that the lands are located in the
7. County of Santa Fe, New Mexico, and are of
8. considerable value. The Commission has been
9. requested to advise the public of the sale and
10. to receive bids thereon. The Commission has
11. accordingly held a public hearing on the matter
12. and has received bids from several parties.
13. The Commission has determined that the lands
14. should be sold to the highest bidder, and has
15. accordingly awarded the lands to the bidder who
16. offered the highest price. The Commission has
17. also determined that the lands should be sold
18. for the purpose of conserving the oil resources
19. of the State of New Mexico. The Commission
20. has accordingly entered an order awarding the
21. lands to the highest bidder, and has directed
22. the Bureau of Land Management to execute the
23. order. The Commission has also directed the
24. Bureau of Land Management to execute the order
25. in accordance with the provisions of the
26. Act of March 3, 1879, relating to the
27. sale of public lands. The Commission has
28. also directed the Bureau of Land Management
29. to execute the order in accordance with the
30. provisions of the Act of March 3, 1879,
31. relating to the sale of public lands.
