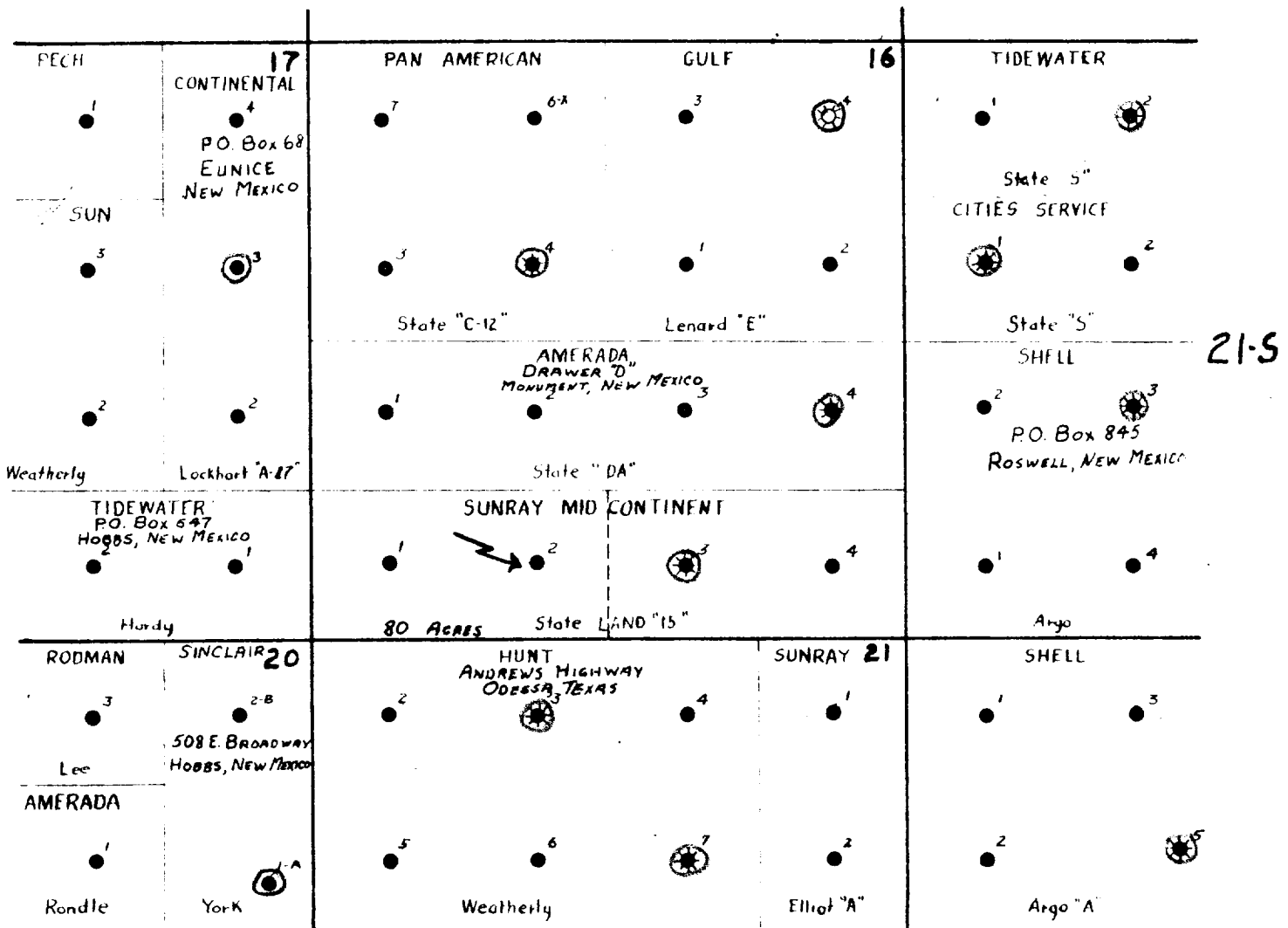
SHOWING DRINKARD AND BLINEBRY WELLS IN VICINITY OF
