- 1/6/89 Howco circulated hole w/10# salt gel.
- 1/6/89 Howco to spot 50 sx class "C" @ 2500'. SI overnight.
- 1/7/89 Tag cmt plug @ 2440'. Contacted Jerry Sexton to approve plug.
- 1/7/89 Howco to establish circulation dn 5 1/2" csg w/good returns on 5 1/2" x 8 5/8" annulus. Pump 106 sx class "C" cmt w/good slurry to pit - did not displace 5 1/2" csg. 5 1/2" csg full of cmt from 323' to surface as well as 5 1/2" x 8 5/8" annulus. Rig dn & rel all contractors.
- 1/9/89 Remove anchors. Clean location. Place dry hole marker on 5 1/2" csg. Project complete.
