

Describe Cause of Problem and Remedial Action Taken.*

The release occurred when the sight glass broke on the production knockout. The sight glass has been replaced.

Describe Area Affected and Cleanup Action Taken.*

The release occurred within the falcon lined facility. Vacuum trucks were immediately dispatched to recover all standing fluids. Concho will have the spill area evaluated for any possible impact from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation activities.
