Describe Cause of Problem and Remedial Action Taken.*
A 3 inch victaulic fitting was leaking at the water production tank. The well was shut in and the tank was isolated to stop the release.

Describe Area Affected and Cleanup Action Taken.*
Approximately 6bbbls of produced water was released into the lined SPCC containment ring. A vacuum truck was dispatched and recovered approximately 6bbbls of produced water from lined containment. All fluid stayed inside the lined SPCC containment. Once fluids were removed the liner was visually inspected by Devon field staff for any pinholes or punctures and none were found. Based on this inspection there is no evidence that the spill fluids left containment.
