
Describe Cause of Problem and Remedial Action Taken.\*

A 3" water line from the heater treater developed a hole, causing the release. Vacuum truck(s) and roustabout crews were called.

Describe Area Affected and Cleanup Action Taken.\*

An approximate area of 20' X 25' and 30' X 50' within the lined/bermed battery. Vacuum truck recovered 129 bbls of the released produced water (99%), the remaining produced water was removed with the gravel (gravel disposed at an NMOCD approve facility). The water line was repaired. **Depth to Ground Water: 50-99' (approximately 50', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 10. Based on the battery being lined/bermed, repairs made and 99% released produced water recovered, EOG Resources, Inc. requests closure.**
