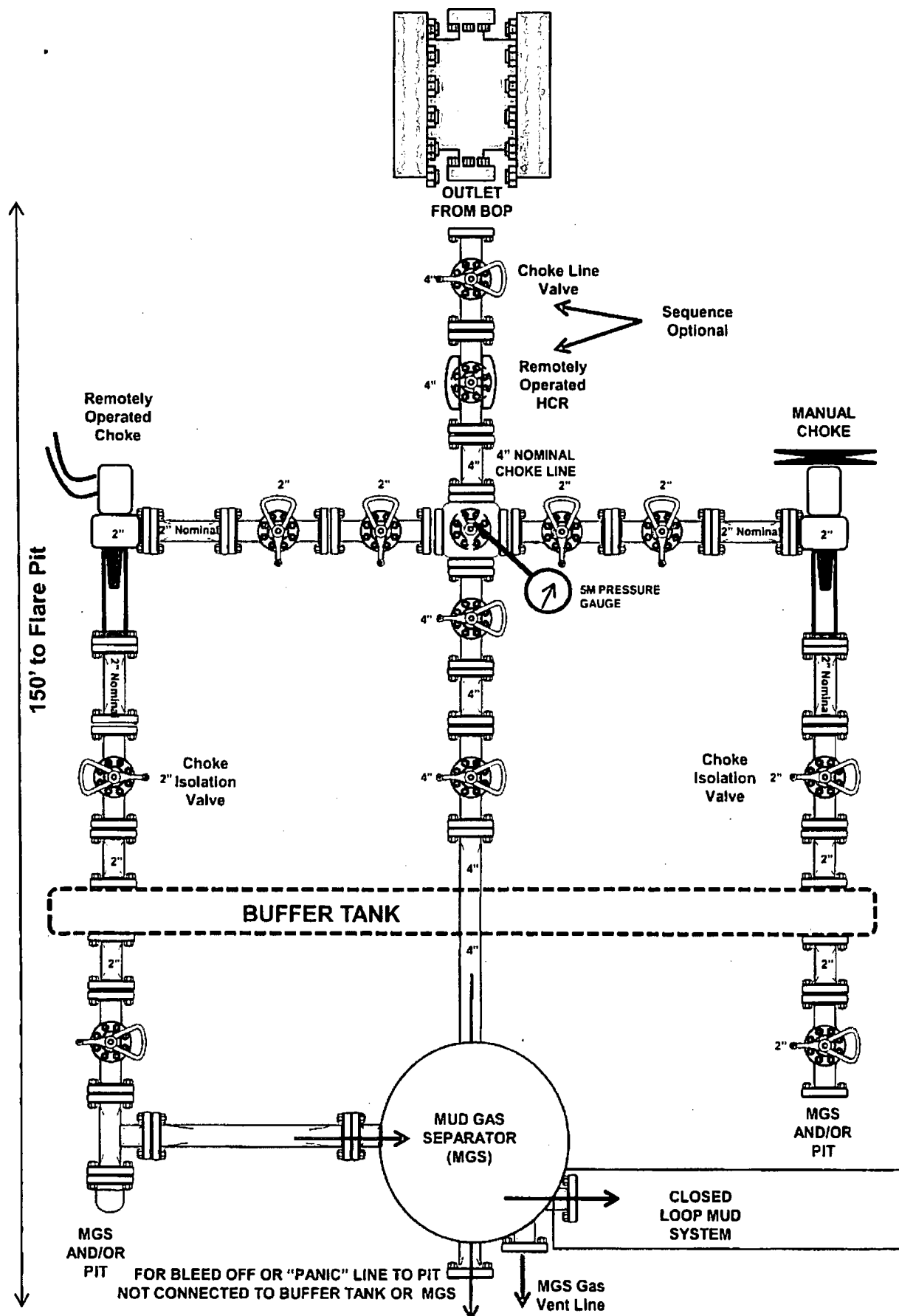

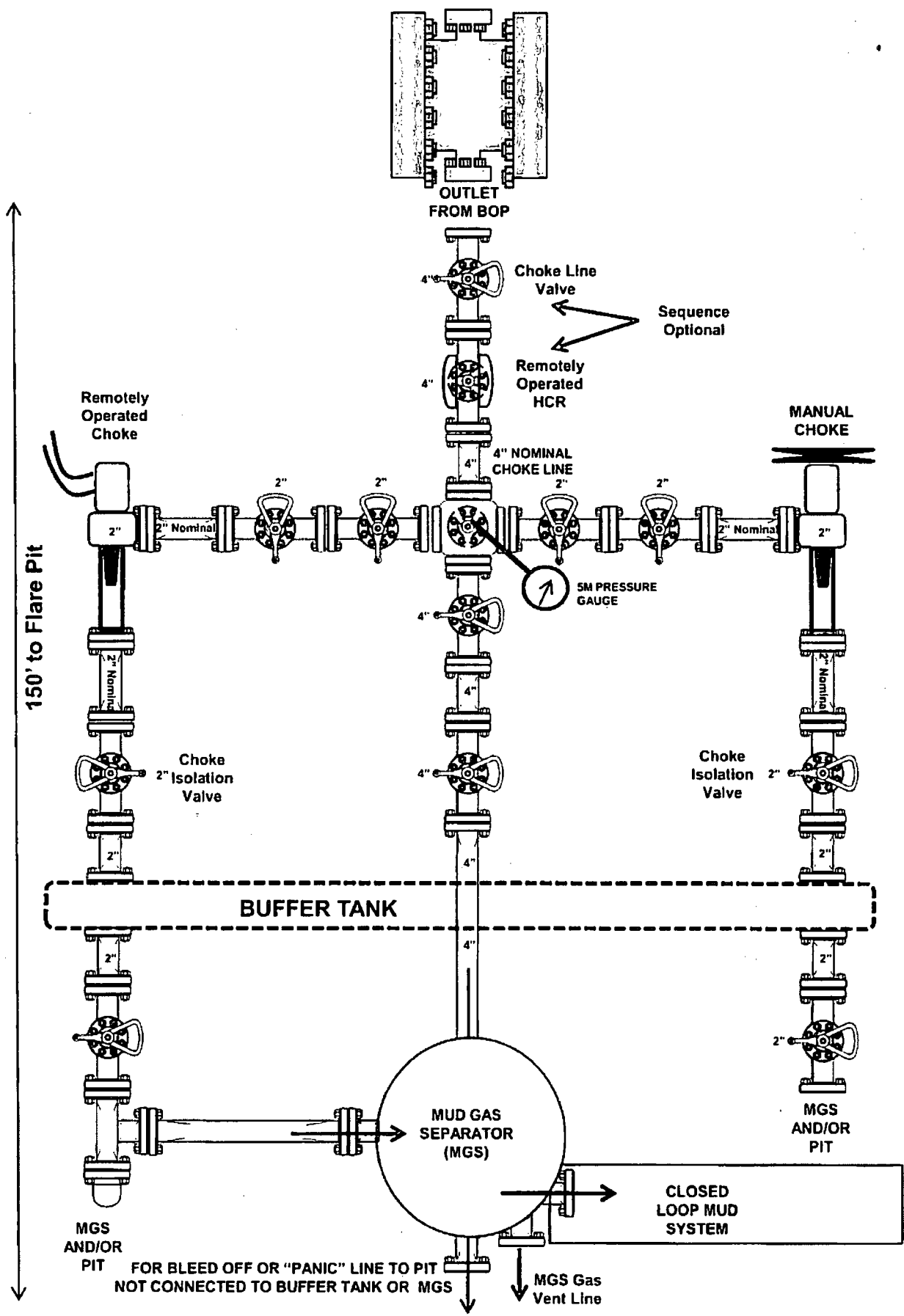

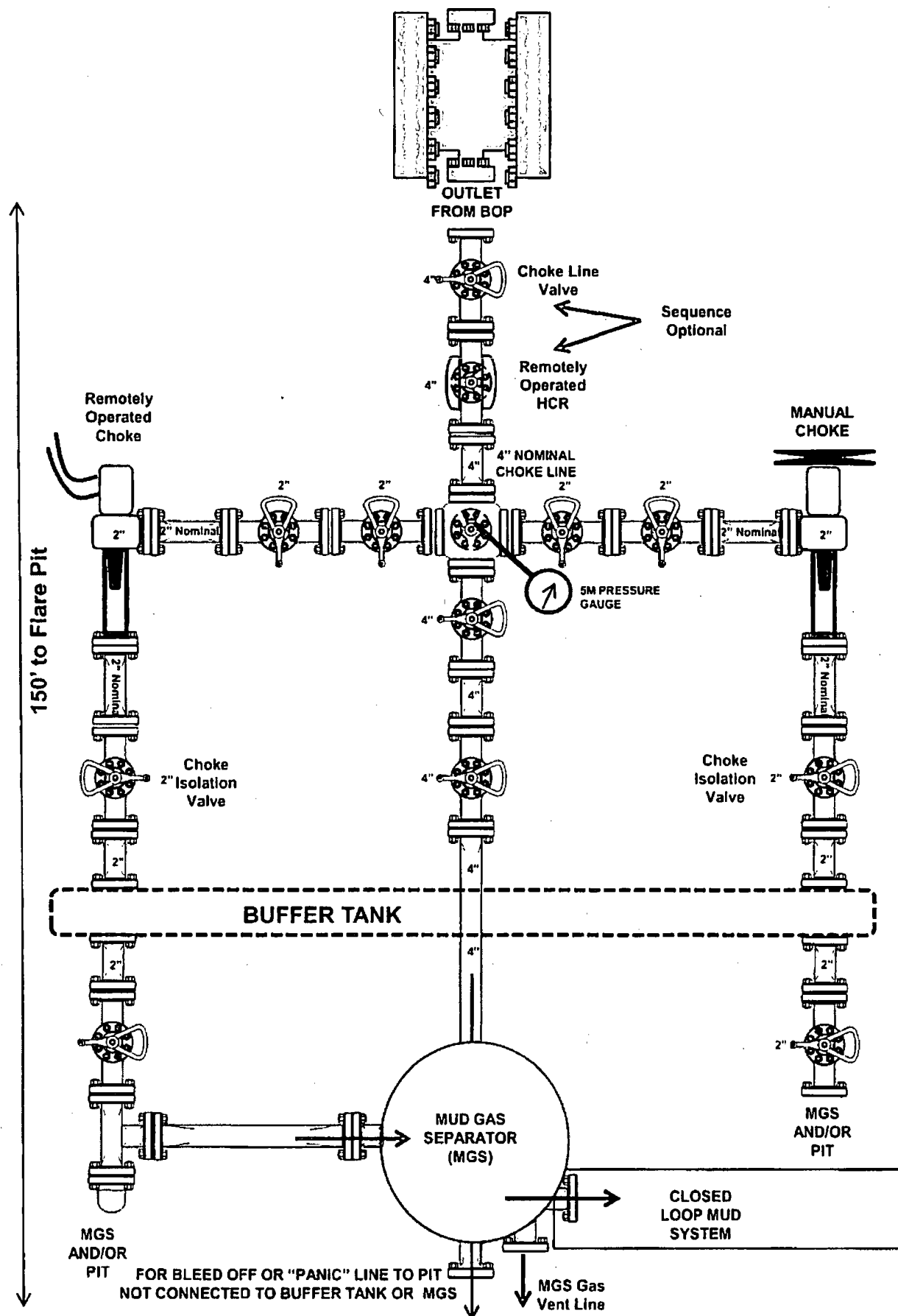
3M Choke Manifold Equipment (WITH MGS + CLOSED LOOP)



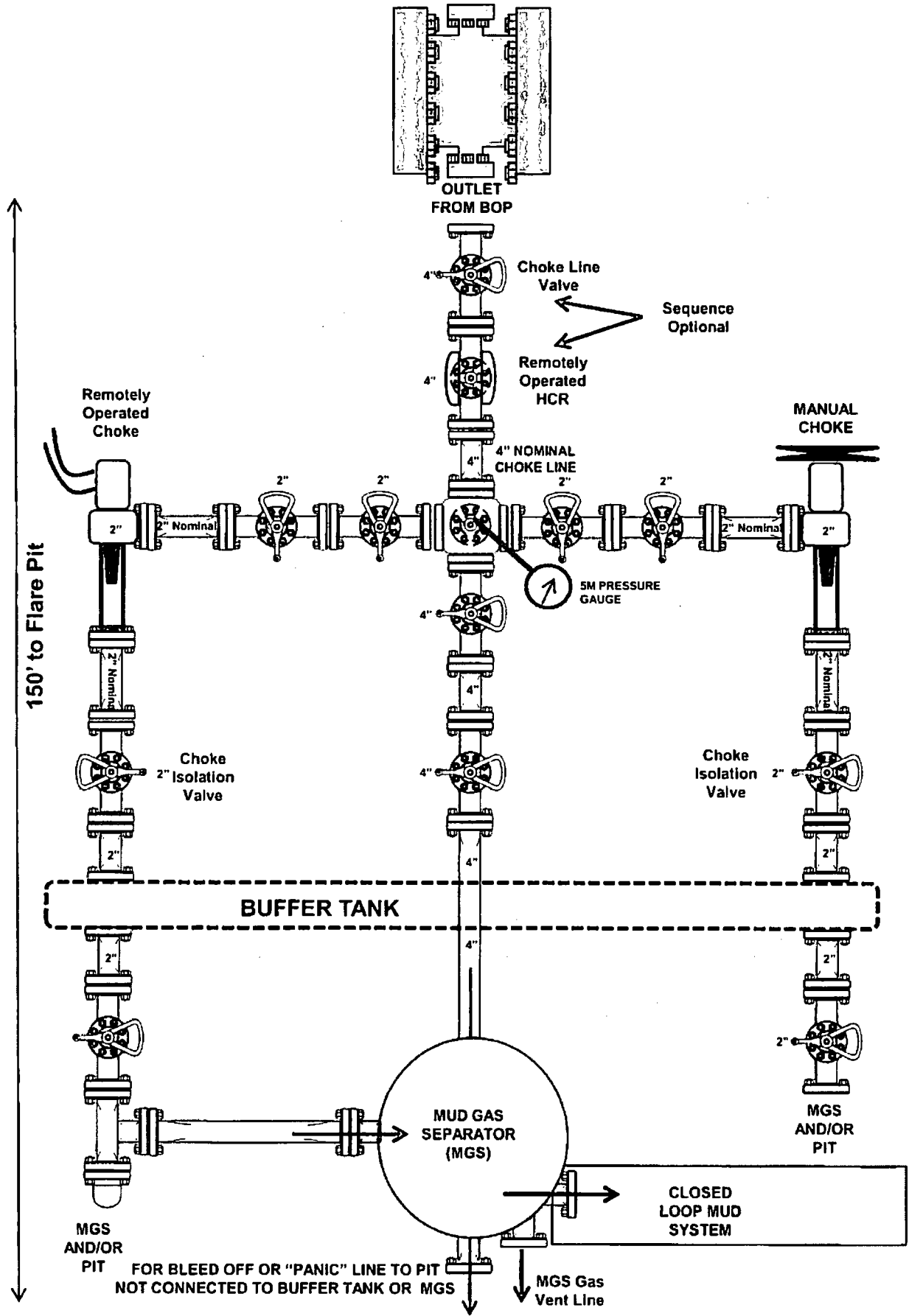
5M Choke Manifold Equipment (WITH MGS + CLOSED LOOP)



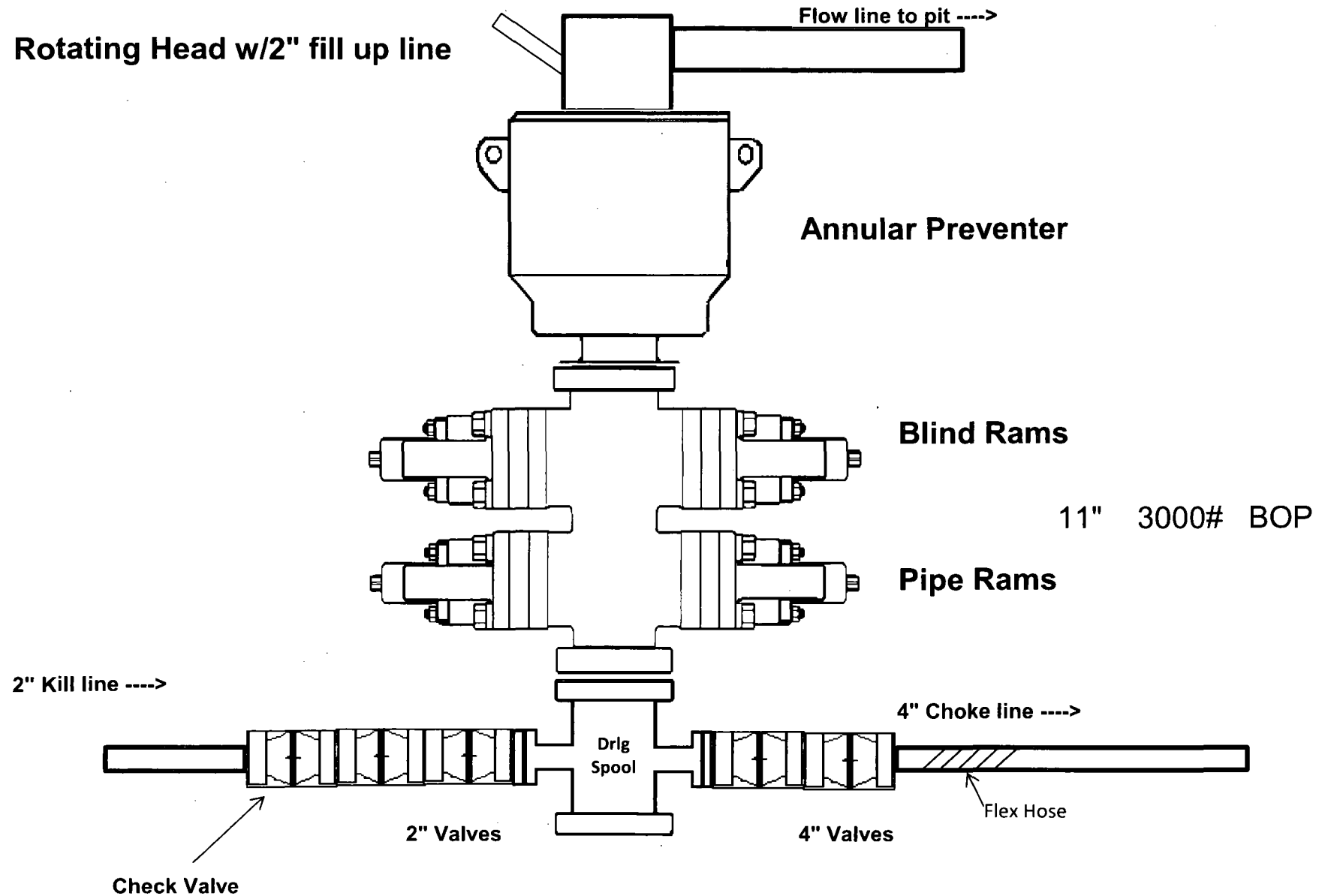
2M Choke Manifold Equipment (WITH MGS + CLOSED LOOP)



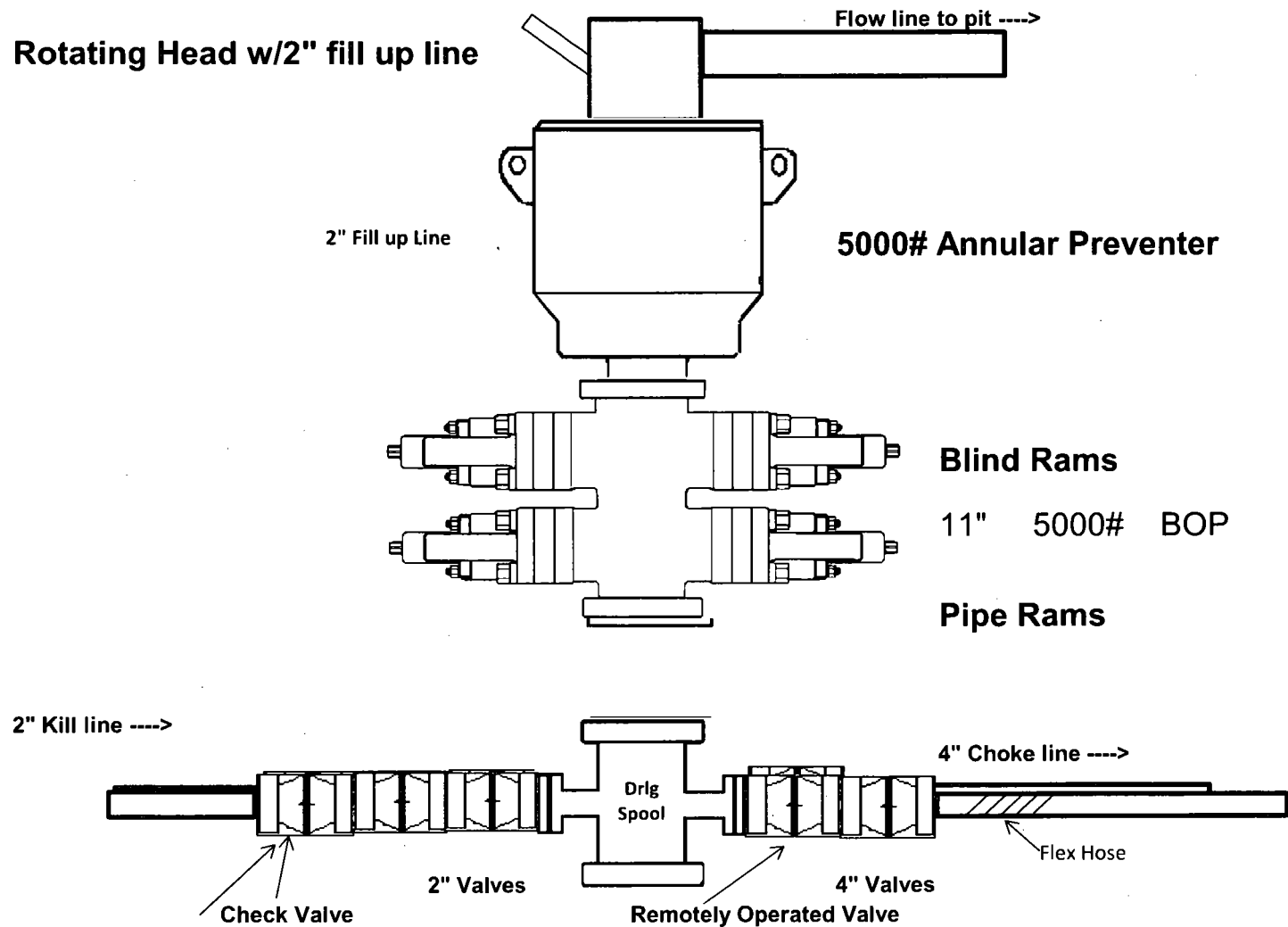
5M Choke Manifold Equipment (WITH MGS + CLOSED LOOP)



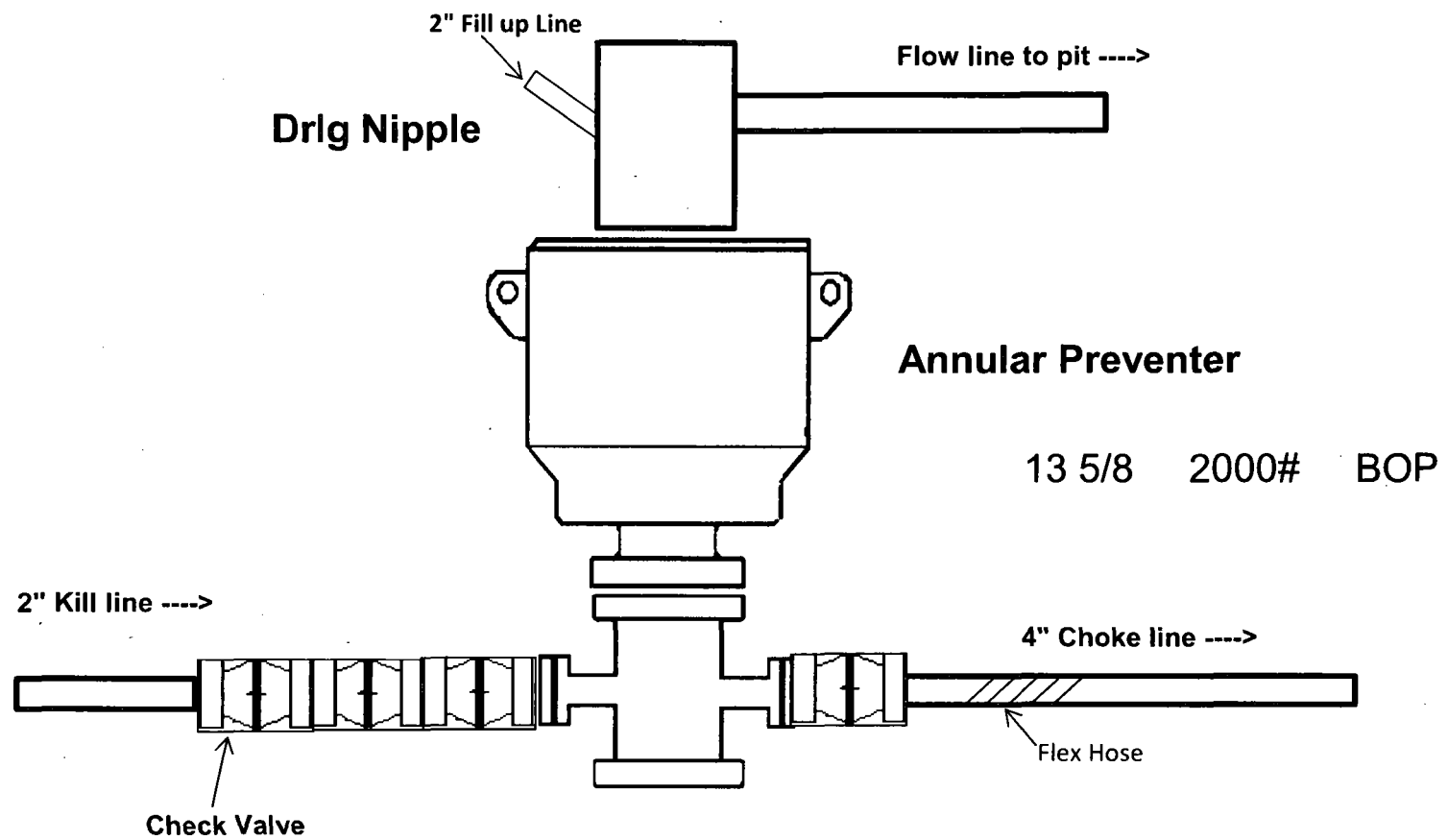
3,000 psi BOP Schematic

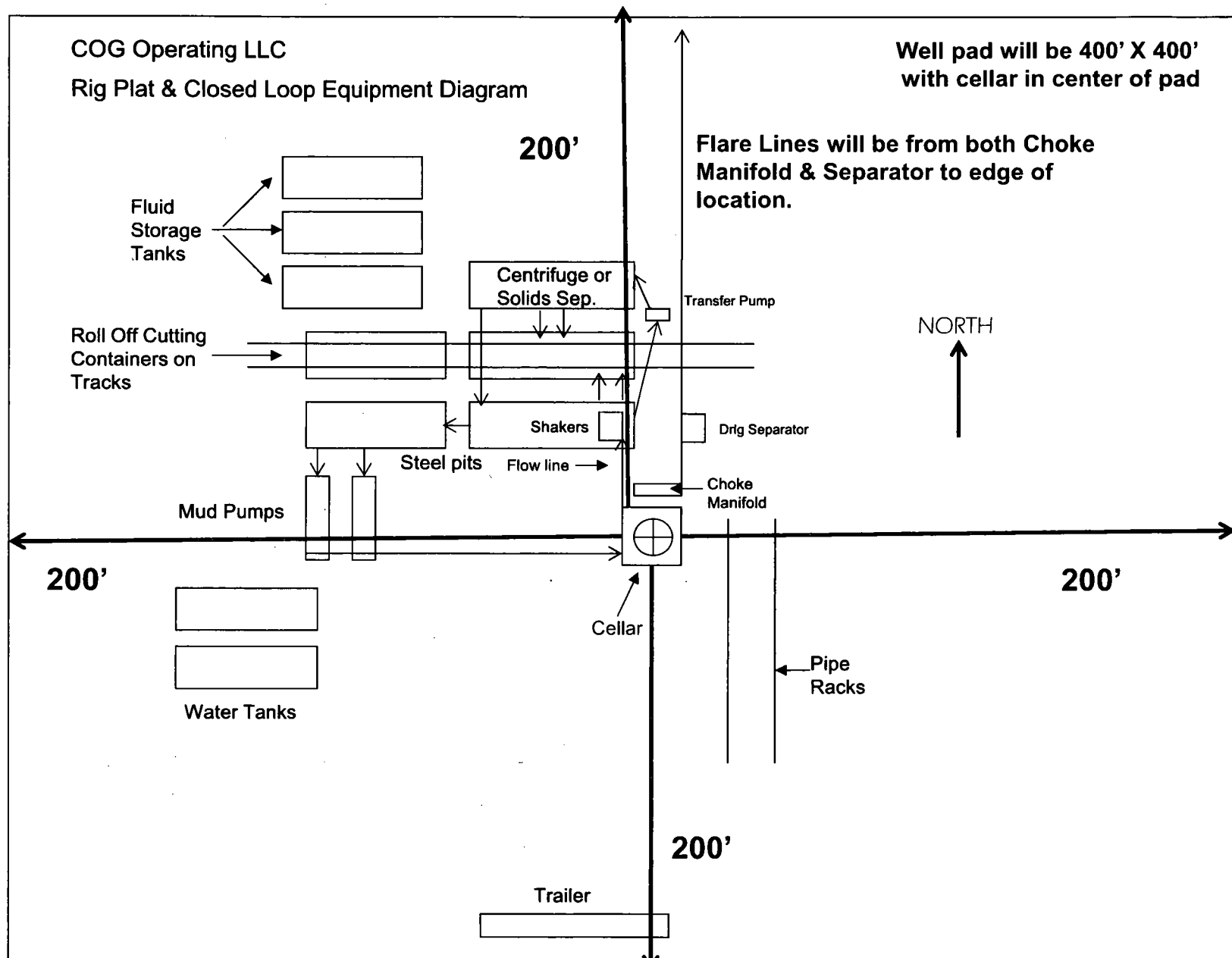
