This release was caused when a transducer malfunctioned and caused the tank gauge to read the incorrect reading resulting in the tank overflow. The transducer has been replaced.

Describe Area Affected and Cleanup Action Taken.\*

This release occurred within a lined facility. A vacuum truck was dispatched to recover all freestanding fluids. Concho will have the spill area evaluated for any possible impact from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation activities.
