Devon Energy Production Co., L.P. (Devon) respectfully requests to have the option to move intermediate casing down to 8,500' due to the close proximity of depletion from multiple active Delaware producers, as well as offset injectors. The offset wells have perforations varying from 7,200' to 8,500'. Setting our intermediate string deeper will allow for us to case off potential loss zones. This will allow us to increase mud weight as necessary for well conditions in the production hole, allowing us to better handle any well control issues that may arise while drilling the lateral. This is a contingency plan based on final drilling results.
