This well failed a MIT test 8-15-2017, as of 9-1-2020 the NMOCD has not received a C-103 or any documentation the well has been repaired. Well has been shut in since 8-15-2017. To get the well back injecting we need to receive a C-103 intent, then a C-103 subsequent with what work was done, well bore diagram and schedule a post workover test. Also, may have lost authority to inject, since no injection since 2017.

In the event that a satisfactory response is not received to this letter of direction by the "Corrective Action Due By:" date shown above, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well.
