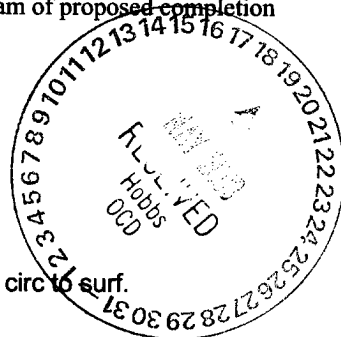

3. Displace hole w/mlf, 9.5 # Brine w/25# Gel P/BBL.
4. Spot 25sx plug 5000-4800(Glorieta)
5. Spot 25sx plug 3300-3100(Queen,DV Tool)
6. Spot 30sx plug 2600-2300(Yates,B-salt)WOC Tag.
7. Spot 30sx plug 1300-1050(8 5/8 shoe,T-salt)WOC Tag.
8. Perf 4 holes @ 300, circ 90sx plug 300-surf 5 1/2 X 8 5/8 to insure cmt behind 5 1/2 was circ to surf.
If unable to pump into perfs, Fill 5 1/2 csg w/30sx plug 300-surf. (Surf)WOC Tag.
9. Install dry hole marker.
