10/17/12 - Hole came in on bottom of Oil Tank. Released 160 bbls of fluid. We lost around 60 bbls and recovered 100 bbls of fluid. The fluid was contained within the firewalls. The Owner of the lease is the Smith Ranch. Since the water table is low, it was never compromised. Talon is going to take over the clean-up. The widest point of the spill is around 50' X 40' the rest is around 10' X 150'.
