Stage 1: Lead w/880sx of PVL (YLD 1.82 WT 13)9200'-14161'

Stage 2: Lead w/210sx of 35.65 PozC (YLD 2.06 WT 12.6), Tail w/180sx of 50:50 PozC (YLD 1.36 WT 14.2) 7500'-9200'

Stage 3: Lead w/600sx of 35.65 PozC (YLD 2.06 WT 12.6), Tail w/100sx of 50:50 PozC (YLD 1.36 WT 14.2) 4900'-7500'

35% excess in lateral open hole

25% excess in vertical open hole

15% excess casing to casing
