This line is expected to carry 500 MCFD @ 75 PSI.

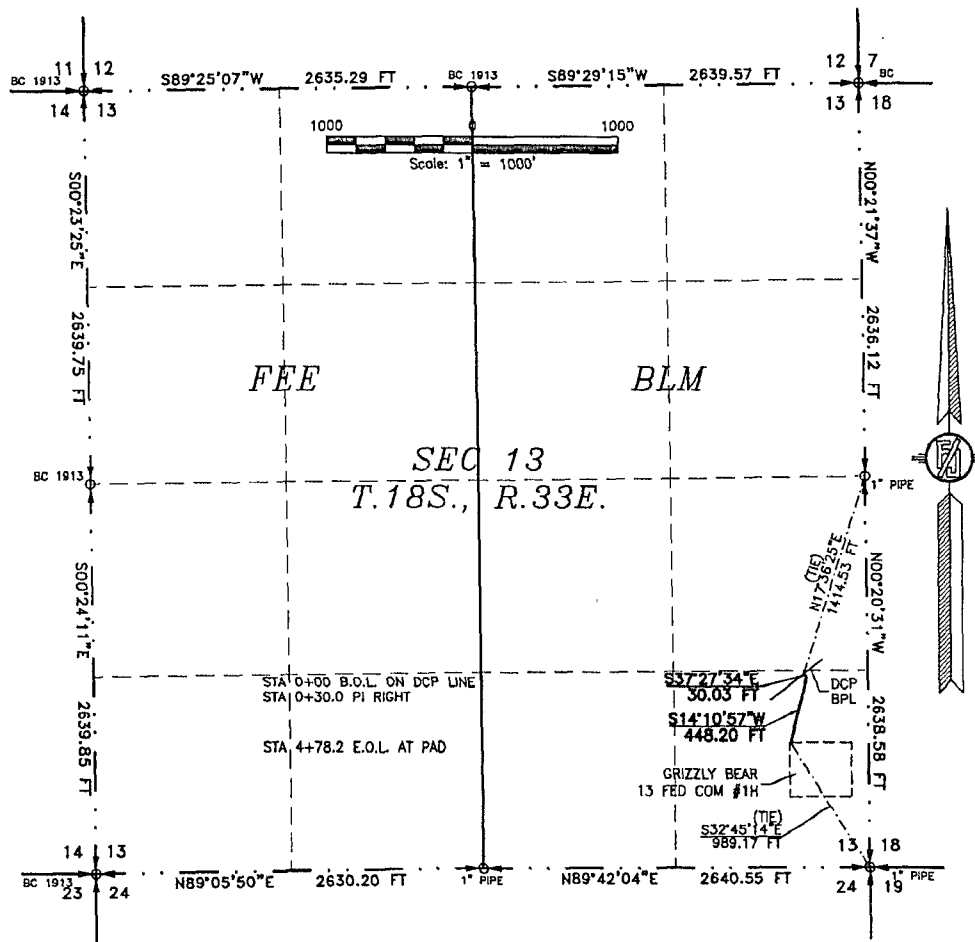
