Cimarex Energy respectfully requests approval to include a 2M diverter system.

Previously approved permit indicates BOP to be nipped up from the base of the 16" casing to TD. Cimarex requests the use of a diverter system to be nipped up on the 16" casing. The diverter system will consist of an annular preventer and a rotating head. It will be tested to 250 psi low and 500 psi high (see attached.)

Cimarex will nipple up BOP as proposed in the approved permit from the base of the 11-3/4" intermediate csg to TD.

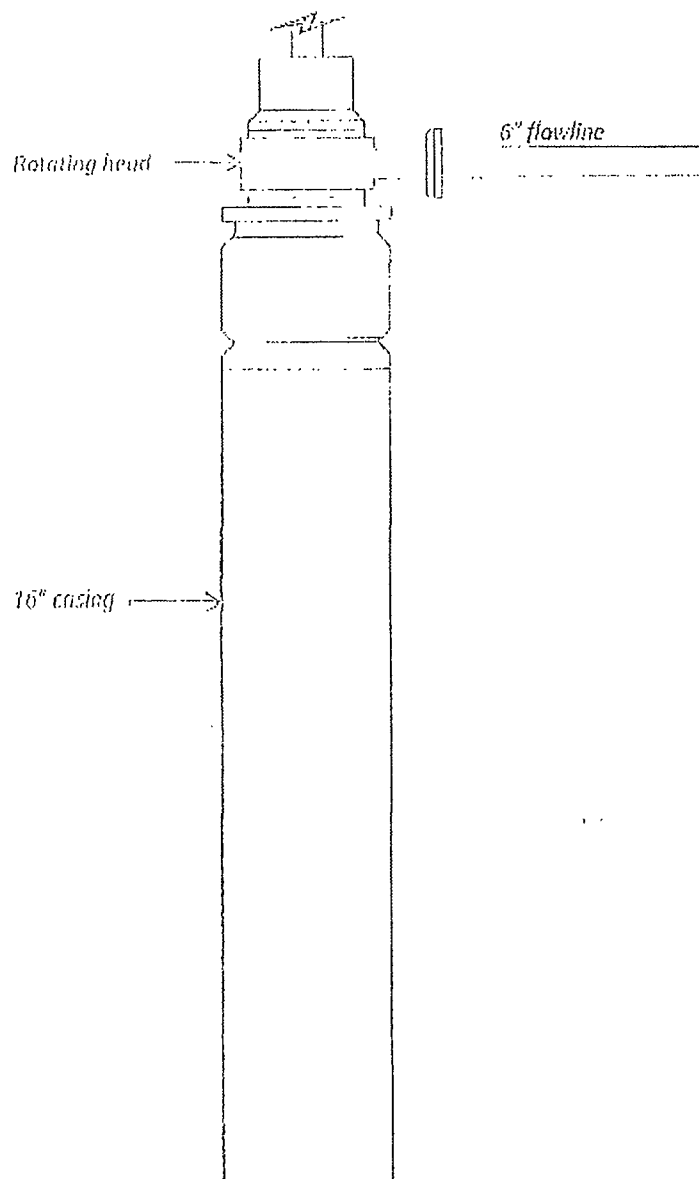
