Operations & Maintenance:

During every hour of operation, the rig's crew will inspect and monitor the fluids contained within the steel tank and visually monitor for any spill which may occur.

Within 48 hours should a spill occur, the NMOCD District 1 office in Hobbs (575-393-6161) will be notified. Please note that notifications may be made earlier to the district office should a greater release occur.

This is in keeping with the reporting requirements of NMOCD's rule 19.15.29.8

Closure:

After P&A operations, fluids will be hauled and disposed to the Sundance Disposal location. (permit number NM-01-0003)

Should this facility not be available, Controlled Recovery, Inc.'s (CRI) location will be the alternative site for disposal. (permit number NM-01-0006)
